

## PHOSPHORUS FERTILIZERS

### Section 665

Any person, including homeowners, renters or commercial applicators, may not apply fertilizers that contain any amount of phosphorus to a lawn or garden without approval from the city. When notified a minimum of 24 hours in advance, the City of Crystal does allow phosphorous fertilizers to be applied to turf grass in its first growing season or to soil which tests confirm is below established phosphorus levels. Anyone in the business of applying fertilizer for hire must obtain a license from the city. A list of licensed applicators is available at City Hall.

Natural fertilizers such as yard waste often contain some phosphorus. The use of composted yard waste to mulch planting areas is encouraged; however, because yard waste is a source of phosphorus, care must be taken to keep these materials out of streets, storm sewers and other areas that may drain directly into water resources.

## BOULEVARD PLANTINGS

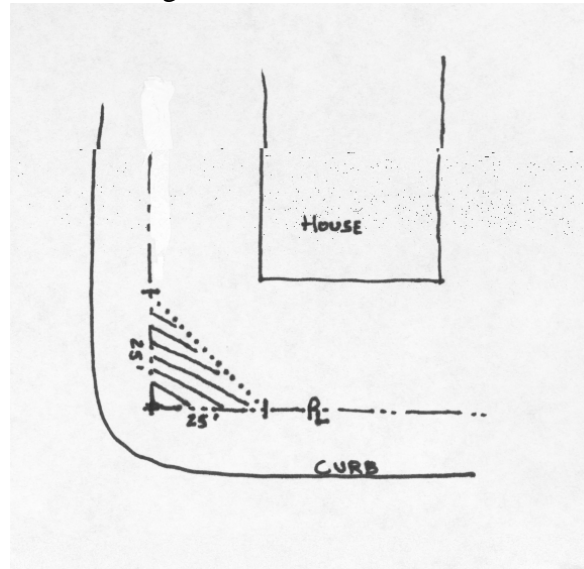
### Section 800.2

Only low growing grass or groundcover may be planted on the first 5 feet inward from the curb. Plants 5 to 10 feet inward from the curb may reach up to, but not exceed 18 inches in height. Plants more than 10 feet inward from a curb have no height restrictions. Planting permits are available from City Hall for any group or individual that wishes to plant a tree within a boulevard.

## STREET VISIBILITY

### Section 515.07

No structures or planting of trees or shrubs shall be permitted within 25 feet of any corner formed by the intersection of street property lines or the right-of-way of an intersecting street (see diagram below). If there is an existing tree in this area, branches must be trimmed to a height of 4 feet from the ground and shrubs must be no higher than 4 feet in height.

## COMPOSTING Section 605.15

Composting is encouraged in Crystal as an ecological way to recycle organic material. Composting not only reduces waste, but it provides a humus-rich soil to use in gardens, potted plants and landscaping.

### **Compost may only consist of the following materials:**

- Grass clippings
- Small twigs
- Leaves
- Garden debris
- Wood chips
- Fruit/vegetable scraps

All compost piles must be located in the rear yard, at least 5 feet away from all property lines and contained in an appropriate manner. Compost bins may be commercially fabricated or constructed of wood and/or wire materials. Bins must be maintained to prevent insect and rodent infestation and undesirable odors. Mixing compost often helps ensure that it receives the air necessary for rapid decomposition.

## GRASS, LEAVES AND BRUSH Section 640

**Grass and weeds must be kept shorter than 12 inches.** Noxious weeds, as defined by the Minnesota State Statutes (1505) are “an annual, biennial, or perennial plant that the commissioner designates to be injurious to public health, the environment, public roads, crops, livestock, or other property.” Noxious weeds include purple loosestrife,

leafy spurge, perennial sowthistle and Canada thistle and must be removed from all properties per Minnesota State Statute.

It is important to remember that leaves, brush and other yard waste are considered refuse and are treated as such according to disposal and storage regulations.

All yard waste must be stored out of public view in an appropriate garbage container, storage building, or garage prior to disposal. All streets, sidewalks, and boulevards must be kept clear of all yard waste. ## SHADE TREE DISEASE Section 2020

To control and prevent the spread of shade tree diseases, such as Dutch Elm and Oak Wilt, the City Forester may inspect any premise for diseased elm trees and bark-intact elm wood. When the City Forester finds diseased or dead trees and there is an imminent danger of further infestation, the property owner will be notified to remove the disease source within an allotted period of time.

## TREE TRIMMING Sections 830 and 1165

Property owners may trim trees on their own property. A person operating a tree trimming or tree removal business in Crystal must be licensed by the city. Tree removal from public land, including boulevards, is not permitted without prior written approval from the city. As a rule, trees growing along streets within 15 feet from the curb belong to and are maintained by the city.

## WOODPILES Section 605.17

The storage of cut firewood is permitted in residential areas, provided the firewood is used on the premises where it is being stored. No more than 4 separate woodpiles are allowed per residential lot.

### **All woodpiles must abide by the following:**

- Located in rear yards on either a decay resistant surface or stacked 4 inches off the ground
- Cannot exceed 5 feet in height, 4 feet in width and 10 feet in length
- Screened with a wall or fence if within 5 feet of a property line
- Cannot consist of elm wood if bark is attached
- Cannot consist of oak wood if pile is uncovered or bark is attached.
